

Support Our Foster Children

There are approximately **850 foster children** in the Santa Clara County Dependency Court System at any given time.

Every one of them has **experienced abuse**, **neglect**, and/or **abandonment**.

Every one of them **deserves a Court Appointed Special Advocate (CASA) Volunteer**.

Child Advocates of Silicon Valley serves foster children aged birth to 21 years old who are placed in the Santa Clara County Dependency Court System by: operating the Court Appointed Special Advocate (CASA) program in Santa Clara County; building enduring community partnerships to broaden and strengthen our impact.; and influencing local policies and decisions that affect the children we serve

We recruit, train and support **CASA Volunteers** who are appointed by a judge to be a mentor, advocate and voice for a child in foster care. Assigning a CASA to a foster child is the intervention needed to reduce the impacts of having experienced trauma.

CASA Volunteers work with legal and child welfare professionals, educators, service providers and family members to ensure the child's voice is heard. Their advocacy enables judges to make the most well-informed decision for each child.
